Re:SIMS Learning Gateway

At Haydon School we use a system called SIMS (School Information Management System) to record data about your child. All Staff use this to record registers, track attendance, enter rewards when students have performed well, enter sanctions to track behaviour and grades to track academic progress. This is a vital tool for us to monitor and to improve the progress that your child makes at Haydon School.
